

# Pahaheke Rd Rallysprint

## 22 February 2020



### 1. JURISDICTION

This Event is a Club Sport Advanced Rally Sprint promoted by the Dannevirke Car Club (Inc) and will take place on Saturday, 22 February 2020 on Pahaheke Road Dannevirke.

The Meeting will be held under the current Motorsport NZ National Sporting Code and its Appendices and Schedules particularly the Club Sport Standing Regulations, Appendix Five, Schedule C.

### 3. THE EVENT

- 3.1. **Venue** The event will be held on Pahaheke and Waituna Road, Dannevirke with documentation and scrutineering at the event HQ near the start line. Pahaheke Road is located off river road in the kumeroa Area and is 100% gravel.
- 3.2. **Length** the event is 5.5 kms long. 100% gravel.
- 3.3. **All vehicles are eligible for all runs**; there will be no elimination runs.
- 3.4. **Official and Observations Runs** there will be one Recce run, a practice run and 3 timed runs ~~both directions~~. The number of runs being dependent upon the total number of entries received, and force majeure on the day.
- 3.5. **Return to Start Line:** each group will be held at the finish end before touring back through the course to the service area when instructed. ~~being sent back under race conditions on 1 minute intervals~~
- 3.6. **Service Park** is in the paddock just prior to the start line. On Waituna road GPS location -40.397863, 175.968163
- 3.7. The **HQ** will be situated in the Woolshed in the service park.

### 4. ENTRIES

- 4.1. **Entries** open with the publication of these Regulations and Close on Sunday 16<sup>th</sup> February 2020. Entries postmarked or emailed after the normal closing date will be subject to late entry fee of \$30 extra (late entries will be taken up until closure of documentation on Saturday 22 February 2020)
- 4.2. **Entry Acceptance** shall be made on the Official Entry Form online system, and to be deemed valid, must be complete in all details and accompanied by the appropriate entry fee. Acceptance will be at the Organizing Committees discretion.
- 4.3. **Entry Fee** will be \$150.00 per entry. **Late Entry Fee** will be \$180.00
- 4.4. **Dual Entries** will be accepted, but it is the responsibility of the competitor to ensure that they are ready to start in the correct starting order to be advised, or the run will be forfeited.
- 4.5. **Number of Starters** will be up to 45.
  - The organizers reserve the right to abandon the event if less than 20 entries are received by the normal closing date.

5. **CLASSES** As this is also round 1 of The Engine Room Sprint Series 2020 classes have been adopted. Full class eligibility can be found at <https://www.dannevirkecarclub.co.nz/files/SERIES-REGS-2018.pdf>

- Class A 2WD 0-1400cc
- Class B 2WD 1400-1750cc
- Class C 2WD 1751cc and over
- Class D 4WD – manufactured after Jan.1st 1996 and all 4WD not eligible for Class E
- Class E 4WD – Pre-1996

5.1. **Best Run** the best time from any of the runs count for the Class and Overall placings.

6. **DOCUMENTATION** Will be held on the day from 8.00am to 9.00am. Competitors must present themselves at documentation for the checking of documents, issuing of competitor numbers and applicable advertising material before presenting the car for audit scrutineering. Cars will not be cleared until numbers and advertising are firmly affixed in the appropriate places on the vehicle. The venue for this is at the event HQ

7. **SCRUTINEERING AUDIT** MSNZ requires all vehicles that will carry a passenger in Clubsport Events to be audited. To ease the load on the day please arrange to have your audit carried out remotely in the week before the event.

7.1. Remote Scrutineering is to be carried out in the week prior to the event. Contact one of the scrutineers listed to arrange a time that suits them.

7.2. If your audit has to be done on the day please contact Peter Weir to arrange.

8. **DRIVERS BRIEFING** A verbal briefing will be given at the Start Line of the venue at 9.15am. A roll call will be held, all drivers are required to attend.

9. **OBSERVATION RUN** The observation run will commence immediately after the Driver Briefing. This run will be in **CONVOY ONLY**.

10. **OFFICIAL RUNS** Cars are expected to run in numerical order. If you wish to run out of order you will need to talk to the COC with a good reason. Lining up out of order may forfeit your run. The seeded entry list and run groups list will be available at documentation.

11. **TIMING** Cars will start at one-minute intervals. The clocks used will be accurate to 0.1 seconds (1/10ths).

12. **ACCIDENT DAMAGE** If you do cause damage to fences or other property you must advise an Official at the HQ caravan situated adjacent to the Start Line. You will be charged for cost of repairs at the cost charged to the Club.

13. **RUN NOTES AND RECONNAISSANCE Run** notes will not be supplied. You may create notes during the observation run only. You may not hold up the convoy to do these notes.

14. **CAR NUMBERS** The car numbers issued to you are the property of the Dannevirke Car Club. You are required to return them to the HQ caravan **BEFORE** you leave the venue. If they are not returned you will be sent an account for \$25.00 per number for their replacement. Please ensure you have tape to affix them to both sides of your car in a clear to read position

**Accommodation** – there is a variety of motels, hotels and camp grounds available in Dannevirke and Woodville. Dannevirke Car Club members may be able to billet some competitors.
